Be it resolved by the City Council of Marshall, State of Arkansas a resolution entitled: a resolution to apply for grant funds to replace/repair batteries and decoders for the city storm warning sirens.

A Resolution authorizing the Mayor of the City of Marshall to apply for a grant on behalf of the City of Marshall.

Whereas, the City of Marshall City Council has determined that the City of Marshall community meets eligibility requirements necessary to apply for a grant under the Arkansas Rural Community Grant Programs, and

Whereas, the City of Marshall Community has presented plans to replace/repair batteries and decoders for the city storm warning sirens; and

Whereas, the City Council of the City of Marshall recognizes the need for the project, concurs its importance, and supports the City of Marshall Community in its efforts to proceed with the same, and

Whereas the City of Marshall Community has furnished proof that they have raised \$ 3,445 through community cash and/or in-kind donations to be applied to the project as a local match;

Therefore, be it resolved that the City Council of the City of Marshall hereby appropriates a sum of \$ 3,445 to complete the local match money requirement for the project described herein;

Be it further resolved, that the Mayor of the City of Marshall is hereby authorized to submit an application of formal request to the Arkansas Rural Development Commission for purpose of securing state grant funds in the amount of \$ 3,445 to aid and assist the City of Marshall Community in executing the proposed project described herein and that the Mayor or Recorder/Treasurer of the City of Marshall is further authorized to administer the grant funds for the same project.


**SECTION 2:** The respective funds in the attached adjustment shall be, and they do constitute, an amendment to the City budget for the year
